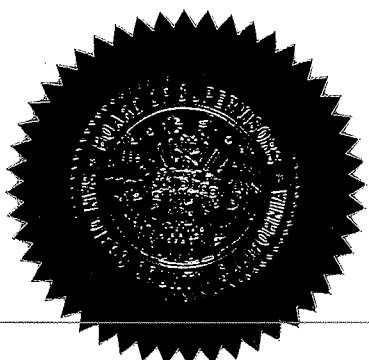
*WHEREAS, the San Diego County Medical Society Foundation is dedicated to breast & cervical cancer screenings for uninsured and those without a medical home; and*
