WHEREAS, Global Wellness Challenges, Winning with Wellness Initiatives and Shape UP HP demonstrate the principles of Live Well San Diego; and

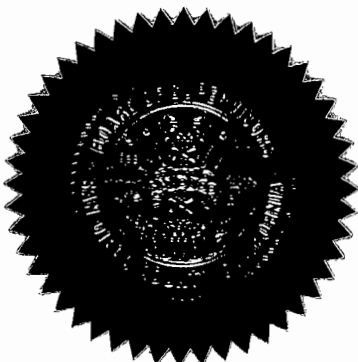
WHEREAS, HP technology innovation is committed to finding new solutions, ideas, and trends to support health and wellness for the County of San Diego and its citizens; and
