**RESOLUTION FOR ADOPTION by NORTH COUNTY AFRICAN AMERICAN WOMEN'S ASSOCIATION  
FEBRUARY 12, 2018 MEETING of the NCAAWA Board of Directors**

A regular meeting of the North County African American's Women's Association Board of Director's was held on February 12, 2018, where a quorum of the Board was present and the following resolution was presented for adoption:

**WHEREAS**, North County African American Women's Association's mission is to provide a support network through education, health awareness, and life skills programs for women and girls in San Diego North County to promote self-sufficiency; and

**WHEREAS**, North County African American Women' Associations envisions an engaged, safe, empowered, and thriving community, with the opportunity for development for all; and

**WHEREAS**, on February 12, 2018 the North County African American Women's Association Board of Directors adopted *Live Well San Diego* as a strategic method to enhance the organization's wellness strategy and engage like-minded partners to assist community residents build better health, live safely, and thrive; and

**WHEREAS**, the work of North County African American Women's Association supports the first component of the *Live Well San Diego* initiative "Building Better Health" by partnering with the County of San Diego by: participating in various runs/walks physically and financially, such as the Live Well San Diego 12k, Susan G. Komen 3 day Race for the Cure, Oceanside Turkey Trot, and other like events that promote a healthy lifestyle for its membership and for the community; and providing education through the bi-annual NCAAWA Women's Conference, with the 2018 conference theme being *Live Well*;

**WHEREAS**, the work of the North County African American Women's Association supports the "Living Safely" component of *Live Well San Diego* by: maintaining a symbiotic relationship with local law enforcement, inviting and encouraging their presence and awareness education at NCAAWA events;


