Resolution in Support of Lawrence Family Jewish Community Center (LFJCC)

Partnership with the County of San Diego's *Live Well San Diego* Initiative

WHEREAS, the health, safety and well-being of residents is of primary concern for the County of San Diego and on September 27, 2017 the San Diego County Board of Supervisors adopted the *Live Well San Diego* vision to achieve healthy, safe and thriving communities; and

WHEREAS, the concept of a 3-4-50 is the centerpiece for *Live Well San Diego*, which shows that three behaviors –poor nutrition, lack of exercise, and tobacco use contribute to four diseases: 1) cancer; 3) heart disease and stroke; 3) type 2 diabetes; 4) respiratory conditions, which account for more than 50% of the deaths in San Diego County; and

WHEREAS, *Live Well San Diego* is the common thread between the work of public and private entities, faith-based organizations, agencies, cities, business partners, and other stakeholders toward a shared vision of healthier, safe, and more self-sufficient communities; and

WHEREAS, one of the LFJCC's key focus areas is Healthy Lifestyles initiative, reflecting the principles of *Live Well San Diego*, and

WHEREAS, LFJCC continues to serve the entire community in educating them about the importance of nutritional eating, regular physical activity and instilling a lifelong commitment to healthy lifestyles, and

WHEREAS, the LFJCC whole-heartedly support the *Live Well San Diego* vision and is committed to supporting healthy, safe and thriving communities, and

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the LFJCC hereby declares LFJCC a *Live Well San Diego* partner. The Chief Executive Officer is hereby authorized to execute documents and perform all acts necessary to carry out the intention of this resolution. This resolution will take effect immediately.
