HONORING ST. PAUL'S SENIOR SERVICES

WHEREAS, the health, safety and well-being of residents is of primary concern for the County of San Diego and on July 13, 2010, the San Diego County Board of Supervisors adopted the Live Well San Diego initiative to achieve the County's vision of safe, healthy and thriving communities; and

WHEREAS, Live Well San Diego is the common thread between the work of public and private entities, faith-based and community-based organizations, cities, business community members, and other stakeholders toward a shared vision of healthy, safe, and thriving communities; and

WHEREAS, St. Paul's Senior Services has shared the values and vision for creating a healthy, safe and thriving society for all citizens in San Diego County and is committed to its mission of providing care that addresses the social, physical, spiritual, ethnic, economic and cultural needs of the population it serves; and

WHEREAS, since 1960, St Paul's Senior Services has committed to providing support services and affordable housing for persons of modest means starting with the establishment of the first Housing and Urban Development building in California in 1963 and working now in partnership with the Celadon and Wakeland housing projects to provide health and social support services to formerly homeless senior residents; and

WHEREAS, St. Paul's Senior Services has made it a priority to provide a safe environment for persons with memory deficits or for those that need a little assistance to live as independently as possible through the establishment of St. Paul's Villa and St. Paul's Plaza, assisted living and memory care residences; and the establishment of the health plan Program of All-Inclusive Care for the Elderly to serve low income older adults in San Diego and Chula Vista with a new program anticipated to begin in 2018 in El Cajon; and


