*WHEREAS, At Your Home Familycare's mission is to provide care that can improve the quality of life for senior citizens, disabled adults and youth; and*

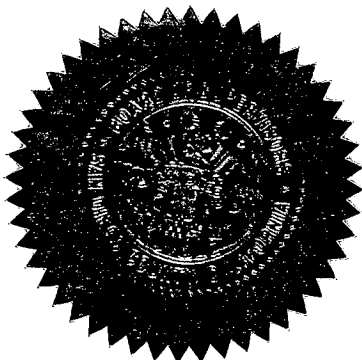
