WHEREAS, since 2001, the Public Authority has committed itself to assisting IHSS consumers in finding home care providers that allow them to remain safely in their homes; and

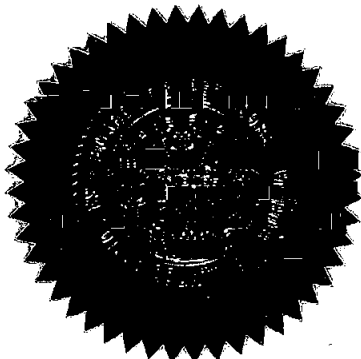

WHEREAS, the Public Authority is embracing strategies of Live Well San Diego by supporting staff participation in the Live Well San Diego 5K and the Annual Alzheimer's Walk, providing videos on topics of methamphetamine abuse, elder abuse, Alzheimer's Disease and other topics as a part of provider orientation, offering Disaster Training and Caregiver Training to all providers and participating in the Board of Supervisors' Alzheimer's Project by serving on the Care Roundtable and implementing key recommendations; and

WHEREAS, the County of San Diego is committed to recognizing and honoring organizations that are dedicated to the best ideals of public service, and the County In-Home Supportive Services Public Authority is one such worthy organization; NOW THEREFORE,
